A personal, standalone tribute beautifully mounted on our memorial towers within the garden grounds. A specific location and side on the tower can be chosen.

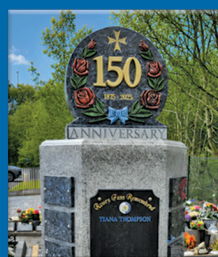

1. Maintenance

- The club reserves the right to prune, alter, or remove plants or features if required for safety, operational, or aesthetic reasons.
- The applicant is responsible for the upkeep of their own plaque/wedge.

2. Personal Tribute Items – are not allowed

- The club reserves the right to remove unauthorised items, if necessary, without permission from the Donor.
- In some circumstances these may be stored for collection for a short period.

3. Conduct and Access

- Visitors may access the Garden during normal opening hours, subject to match day restrictions and safety rules.
- The Garden must not be used for the scattering of ashes or placement of unauthorised items without prior permission.

4. Liability

- The Club accepts no responsibility for loss, theft, or damage to the Garden or its contents due to interference, weather, or other causes.
- The Donor releases the Club from all liability arising from the Garden or its use.

5. Lease period

- The individual memorials (plaques or wedges) remain the property of the applicant, the position within the memorial garden is leased for an initial period of 10 years.
- Once the 10-year period lapses, the Club or Stevenson Memorials may contact you to discuss renewal.
- The applicant may be able to extend the lease or take the plaque/wedge home.
- If the applicant cannot be contacted the memorial item will be stored for an undefined period.

6. General

- The applicant acknowledges that the memorial garden is located on property owned and managed by the Club.
- The memorial garden will remain in place at the discretion of the Club.
